- **99. Minutes of the previous meeting,** held Monday 10th February 2020 were read.

- **97 B.** A member proposed refurbishing the kitchen. The meeting agreed that Cllrs RB and PF would look in to the requirements.
- Cllr RB has agreed to arrange a meeting with a joiner to get quotes for replacing the doors and a complete refit of the kitchen.

101. Ratification of the minutes of the previous meeting.

105. Charges and Pay Review.
