105.01 Tot's Explore

Representations were made from Tot's Explore and residents as to why Tots Explore have to pay 3 times as much on a Saturday as to what they pay Friday . Strong opinions were expressed.

A discussion then took place.

The Chair reported that the Council had agreed that the first hour for Special education need and disabilities would be free of charge for Tots Explore any hours after that would be charged at £15 per hour and further stated that the council had to justify all costs.

Ms Tracy Smith proprietor of Tots explore stated that due the increased costs they would close on Saturdays.

105.02 Public visibility of the police.

A member of the public commented that there should be more more public visibility of the police. The Chair stated that the parish had no authority over the police but recommended that members of the public should ring 101 for anti-social behaviour issues.
